### **Trainee Visit and Pro Bono Information Day**

In March, we were delighted to welcome a group of postgraduate legal trainees from Germany. Admittedly, their initial idea of pro bono was gleaned from US-based t.v. series, so we were happy to share our real-world insights. We discussed the idea of effective access to justice, our role in the matching process, and dilemma's in pro bono collaboration between global law firms and NGOs. We sent them on their way with German pro bono resources and the message that all lawyers can contribute to justice, no matter their specialty.



#### Startup & Stichting Rechtswinkel

We are proud to announce the founding of a new free legal advice clinic: The <u>Startup & Stichting Rechtswinkel</u> (SSRW). The initiative hopes to address the need for legal guidance during an organisation's initial phase of startup and registration. It has its roots in the thematic law clinics held with PBC, our partner firms and the Amsterdam Law Hub in 2022.

We share some highlights of our conversation with two of the organization's mentors, **Dr. Marleen van Uchelen** and **Frances Singleton**. Marleen is an associate professor at the University of Amsterdam, candidate notary at our partner firm Houthoff, and specializes in the law on foundations. Frances is the Head of Research and Innovation at the UvA Law Hub and Rechtswinkel.

## What is the value of the Rechtswinkel for students eager to gain pro bono experience?

"The SSRW offers valuable, hands-on skills training for students and gives them insight into the types of questions that businesses tackle during the startup phase. It also teaches students to pay attention to legal design - how they're conveying the information that they share with clients."

### What is the rationale behind combining assistance for startups and foundations at one Rechtswinkel?

"This Rechtswinkel stands out for its focus on startups with a social mission and non-profits. For many startups, it is important to think about shaping their social purpose from the beginning. When the enterprise is making profits, how do these profits benefit the mission?

The distinction between profit and not-for-profit organisations is less sharp these days, just look at the initiative of social enterprises in the Netherlands (maatschappelijke B.V.). In practice, new organisations have many questions about this, including the possibilities and impossibilities of using a foundation.

**Success Story: Social Security for in-Home Caregivers** 

Pro Bono Connect is proud to have facilitated collaboration between **Bureau Clara**Wichmann and Houthoff in the following case:

On 30 March 2023, the Central Appeals Council <u>ruled</u> that **private in-home** caregivers (PGB-zorgverleners) who work less than four days **may not be** excluded from entitlement to social security, because this leads to indirect discrimination against women who make up a majority of this group of caregivers. The ruling has major implications for tens of thousands of in-home caregivers who currently have no social safety net.

The case was brought by women's rights organization <u>Bureau Clara Wichmann</u> and the <u>Dutch Association for Women and Law Clara Wichmann</u>, in support of domestic worker Carol Kollman. PBC partner firm Houthoff provided legal counsel on a pro bono basis.



Follow <u>Bureau Clara Wichmann</u> for more updates, including the awaited appeal hearing of their case for **free contraception** on June 19th.
